The rate should be quoted both in figures and words per day programme. The quotationer has to attach **D-Call amounting Rs. 2500.00/- (Rupees Two thousand five hundred) only in favour of the District Magistrate & Collector, North Tripura, Dharmanagar** from any Nationalised Bank payable at Dharmanagar.


Two separate rates should be quoted for IEC activities in the following areas.

1. **Group -I: Kadamtala, kalacherra, Jubarajnagar and Panisagar Block areas for covering all GP/VC.**
2. **Goupr -II: Dasda, Laljuri, Jampui hill, Damcherra Block areas for covering all GP/VC.**

The sealed cover of the EOI should be captioned "**Expression of Interest**". Sealed EOI should be dropped in the Tender Box, kept in the Chamber of Senior Deputy Magistrate of this office of the undersigned within **03:00 PM** during office hours within **16th May, 2016**, from the date of issue of this notification.

The EOI will be opened on the same day at **04:00 pm** if possible in presence of such parties or their Authorised representative who may remain present at the time of opening of the EOI.

3. Necessary instruments like Loptop, Projector, Generator are to be provided by quotationer for the for the activities.
4. The programme is to be conducted preferably in the evenings & 2 or 3 spots are to be covered in a day as per the scheduled chart from District and with the involvement of the Block and VC/GP functionaries.
5. The vehicle engaged should have up to date registration, tax clearance, third party covered insurance or other tax / charges as applicable. The vehicle should comply with all pollution control regulations and norms.
6. The participant (NGOs & Clubs) that are located in Panisagar & Dharmanagar area can only participate for Gr - I and the (NGOs & Clubs) that are located in Kanchanpur area for Gr-II.
7. All participants should enclose registration certificate of the organisation, experience certificate of similar activities, etc., along with the EOI.
