


**Terms & Condition for Supply of Joint Benches in different Schools of North Tripura
under BADP Scheme.**

1. The Tender box will be kept open at the Development Section of DM's Office, North Tripura in between **16th May '16 to 31st May 2016**. (Working Day/hours only) up to 4 PM.
2. The Rates shall be given Block Wise separately in separate sheet of paper with signature/seal.
3. The drawing Sketch of Joint Bench model is also enclosed.
4. Tenders will be opened on **31st May 2016 at 4.30 PM**. Any persons interested may be present at the office of the Sr. Deputy Magistrate, North Tripura during the opening of Tender box. No separate Notice/information will be given.
5. Intending supplier should have all necessary documents like Valid Trade License, PAN Card & Income Tax & VAT clearance certificate.
6. D-call of **Rs. 5000/- (Rupees five thousand) only** should be deposited alongwith the quoted rates as security deposit in favor of **Senior Deputy Magistrate, O/o, the DM & Collector, North Tripura** from any Govt. recognized Bank,
7. All items should be supplied within **45(forty five)** days from the date of issue of the supply order.
8. All delivery shall be made to the respective schools in good condition and obtain written receipt from the headmaster/Teacher in-charge. The receipts are to be enclosed during submission of Bills.
9. The Quoted Rates shall include VAT @ 14.5 % which will be deducted from the bill raised and
10. Inferior quality with respect to wood quality, varnishing, overall finishing, etc will be rejected and no payments shall be entertained.
11. The Bills shall be submitted with all relevant papers in Triplicate to the District Magistrate & Collector, North Tripura.
12. Before supplier order is issued to the supplier, one complete joint bench sample shall be shown to the District Education Officer, North Tripura and the undersigned. Only after full satisfaction, formal supply order shall be issued.
13. The authority reserve the right to reject any quotation without assigning any reasons and also reserves the right to cancel the tender process any time without mentioning any reason.
14. If the supplier fails to supply the goods within the stipulated period mentioned in above point No. 7 then the supply order may be cancelled and may be placed to another bidder in same rate.

Joint Bench	Wooden joint bench double size measuring having desk of 0.17 x 0.40 x 0.90 cum, bench of 0.3 x 0.90 sqm, 4 long wooden pillars of 0.75 x 0.01 sqm, 4 short wooden pillars of 0.45 x 0.01 sqm and 4 side wooden runners of 0.75m long, made of Teak Wood with complete polishing and varnishing.



- 1- Short vertical wooden pilaar of 0.45 m long and 0.01 m width.
- 2- Sitting wooden bench of 0.90 m long and 0.03 m width.
- 3- Horizontal wooden runners of 0.75 m long.
- 4- Long vertical wooden pillar of 0.75 m long and 0.01 m width.
- 5- The gapping of the desk of 0.17 m.
