SHORT NOTICE INVITING QUOTATION

On behalf of the Governor of Tripura, invited sealed quotation with **Brand and specification wise rate within ceiling Limit** by the undersigned in the plain paper for supply of **Musical installment (Annexure-A)** up to 3.00 PM. of 30/06/2016 (office hours and days only) from interested bonafide and eligible vendor, which is require for implementation of SCW and BEUP scheme under Dasda R.D. Block, North Tripura.

The rate should be quoted both in figures and words as per prescribed Performa in the plain paper **within ceiling Limit (Shown in Annexure-A)**. Quotationer should also submit required documents and D-call amounting to Rs.1,000/- (Rupees one thousand) only in favour of the undersigned from any nationalized bank along with the tender. Any incomplete quotation should be summarily being rejected. Performa of tender form may be purchase from the office of the undersigned on cash payment of Rs.10/- (Rupees ten) only (non-refundable) up to 2 P.M. on 30/06/2016 (office hours and days only).

The tender box will be kept open for dropping of tender by the intending tenderer in the office chamber of the undersigned from 20.06.2016 to 30.06.2016 and time from 10:00AM to 3: PM except Government holiday and the box will be opened on 30.06.2016 at 3:30 PM if possible. If the last date of tender dropping/opening tender becomes paralyzed due to any unforeseen reason the next Government working day will be the last date of dropping of tender and opening of tender box or to be notified accordingly. 

Terms & Conditions:-

1. **The lowest quotationer will be selected as per expected rate and specification.**

The lowest quotationer will have to be supplied the items as per supply order within three days from the date of receipt of supply order from the office of the Block Development Officer, Dasda R.D. Block, North Tripura. If supplier fails to supply the item as per requirement within three days than the security money as deposited in the shape of deposit-at-call will be forfeited.
3. The lowest quotationer will have to supply the ordered materials as per **selected specification**. No inferior or duplicate materials will be entertained by the undersigned. In case of such supply the D-call money will be forfeited as usual course and BDO's office, Dasda R.D. Block North Tripura shall take initiative to declare the concerned firm as black listed.
4. Necessary statutory deduction will be deducted from bill as per rule.




