Following SNIT'S may be inspected by the interested bidders up to 05/07/15 (office hours and days only) in the office of the undersigned. Bidders should quote the rates as per prescribed Performa in the Non-Judicial stamp paper of worth as shown below. Bidders should also submit required documents and earnest money (to be deposited in the shape of D/Call in favour of the undersigned on any Nationalized Bank of India) along with the tender as shown in below. Any incomplete bid should be summarily being rejected. Performa of tender form may be purchase from the office of the undersigned on cash payment of Rs.10/- (Rupees ten) only (Non-refundable) up to 05/07/2015 (office hours and days only).

The tender should only be dropped in the specific tender box kept in the office chamber of the undersigned up to 3.00 PM. and the box will be opened on the last day at 4.00 PM if possible. 2. The quoted rate should not exceed the approved rate of R.D. Department, i.e. Rs.2,000/- (Rupees two thousand) only per signboard.
3. The materials of signboard must be of approved standard quality.
4. All delivery of signboards along with wording, work site fitting fixing with CC footing shall be completed within the specified period as mentioned in the supply order to the concerned Implementing Officer. If the lowest tenderer fails to deliver the same within the stipulated period specified in the supply order, the security money as deposited in the shape of deposit-at-call will be forfeited without any communication and undersigned shall take alternative arrangement for the same.
5. Actual date & time of delivery and fitting fixing of signboards shall be fixed with prior contact with the Implementing officer by the supplier.
6. Bill/Bills should be raised in triplicate after obtaining certificate from the Implementing Officer, (I/O) in this effect that the materials so received by the implementing officer, (I/O) in good condition as per supply order.
7. Any kind of damages (inconspicuous/in scribble manner) will be replaced by the bidder without any extra payment.
8. Necessary statutory deduction will be made from the bill.
