

In exercise of the power conferred by rule 3 and 3A of the Tripura Municipal (Delimitation of constituencies) Rules, 1994 read with Section 12 Tripura Municipal Act, 1994 the undersigned hereby publish the draft of this order dividing and determining the Panisagar Municipality into wards in accordance with the provisions of the aforesaid Act and the said rules indicating in the Schedule below the name of the Municipality in column (1), number of members to be elected to the Municipality in column (2), number of the constituency in column (3), the extent of constituency in column (4) constituency or constituencies reserved for SCs and STs in column (5) and constituency or constituencies reserved for women in column (6) for the information of persons likely to be affected thereby.

It is notified for information of all persons in accordance with rule 4 of the aforesaid rules that any person or institution or any other interested party may submit their objections or suggestions against the draft order by addressing to the undersigned at the Office of the undersigned or through the Sub-Divisional Magistrate of the Sub-Division in which the Municipality is situated within 7 (seven) days from the publication of this notification.

The draft will be taken up for consideration after expiry of 7 (seven) days from this day and any objection or suggestion with respect thereto which may be received by the undersigned before that date shall be duly considered.

Subject:- Delimitation of Constituencies(Wards) of Panisagar Municipality.

State Govt. (U.D. Department) vide Notification No.F.24(1)-UDD/DUD/2010/3826-79 dated 20-07-2015 has fixed the date for publication of the draft order and the final order relating to delimitation of Constituencies of Municipalities on 31-07-2015 and 17-08-2015 respectively.

State Govt. (U.D.Deptt.) has also determined number of population (11,073), total nos. of seats(11), seats reserved for ST (0), seats reserved SC(04), seats reserved for women (05) for Panisagar Municipality for the next forthcoming General Election vide Notification No.F.24(1)/UDD/DUD/2010/3748-801 dated 20-07-2015 and has also issued order regarding guidelines for delimitation of Constituencies (wards) of the Municipalities vide No.F.24(1)/UDD/DUD/2010/3925-68 dated 20-07-2015.

Accordingly, field survey has been done and existing population has been collected from Panisagar Municipality Area/ boundary of the different constituencies(wards) have been organised maintaining geographical compactness and even distribution of population of different constituencies(wards) order vide No.F.24(1)/UDD/DUD/2010/3925-3768 dated 20-07-2015 issued by the U.D. Department, Govt. of Tripura regarding guidelines for delimitation of constituencies (wards) of the Municipalities have also been followed.


While delimitation of constituencies, provisions laid down in "The Tripura Municipal (Delimitation of Constituencies) Rules,1994" as amended from time to time regarding reservation of seats for STs, SCs & for women has also been followed.
