**SHORT NOTICE INVITING QUOTATION (3<sup>rd</sup> call)**

Sealed quotation are hereby invited in plain paper from the owner/firms/agency/manufacturers/ authorized dealers of Tripura for hiring of 01 (one) no. vehicle(car) preferably MUV in well furnished and good condition and manufactured not before the year 2013, on contract basis for use in the **Office of the Programme Officer(Block Development Officer), MGNREGA, Kalacherra RD Block, North Tripura** with the following terms and conditions:

- 1) Quotation should be submitted in sealed cover subscribed "Quotation for hiring of vehicle" and should be addressed to the Programme Officer (BDO), Kalacherra RD Block, Kalacherra, North Tripura.
- 2) Sealed quotation is to be dropped in the Office of the undersigned up to 3:00 PM of the 30<sup>th</sup> July, 2015 during all working days.
- 3) The quotation will be opened at 3.30 PM on 30<sup>th</sup> July, 2015 in presence of the quotationer or their representative, who are willing to attend. The quotationer/ their representative who are present at the time of opening of the quotation should sign in the register.
- 4) The successful quotationer is required to execute an agreement for the satisfactory performance of the contract for 01 (one) year.
- 5) The successful quotationer of the vehicle shall maintain all up to date records as per the Motor Vehicle Tax, License of the driver, vehicle insurance documents etc. and shall be presented before the MGNREGA officials for verification as and when required.
- 6) The successful quotationer shall bear all expenditure in connection with the maintenance of the vehicle during the contract period.
- 7) The quotationaries are to quote the detention charges per days, mileage per KM separately.
- 8) The payment of vehicle bill will be subjected as per availability of fund. The quotationer will not be entertained any kind of pressure regarding payment of bill.
- 9) The undersigned reserves the right to reject or accept any quotation without assigning any reason.
- 10) The undersigned reserved the right to cancel the process of quotation at any time without assigning any reason.
- 11) The undersigned will also be not responsible for any loss of life or any injury to the driver, or any third party caused at the time of performing bonafied tips of undersigned during the period of contract.
- 12) The successful quotationer will be responsible for damage or injury any person, property materials, equipment or any other article cause due to negligence of his driver, or ill maintenance of the vehicle hired by the undersigned.
- 13) In case, the successful quotationer discontinue the contract and fails to supply vehicle as per the agreement within the contract period, then at the discretion of the undersigned, vehicle will be arranged though another tender of by negotiation or with the next higher quotation, who had offered to supply the vehicles on contract basis and the loss if any, caused as may be fixed by the undersigned shall be recovered from the defaulting contract.




- 14) The contractor is liable to make a suitable alternative arrangement of vehicle if the vehicle on contract is under repair/ in case of any inconvenience is experienced in the performance of trips/ due to other reason, failing which alternate arrangement will be made by the undersigned at the risk and cost of the contractor and the amount will be deducted from any amount due to the contractor by the undersigned.
- 15) It will be the responsibility of the supplier to see that his driver possesses valid driving licence and the supplier will also be responsible in case a charge on the driver due to violation of traffic rules, or for any other penalty impose on driver, or the vehicle owner.
- 16) The contractor as well as driver of the vehicle shall obey all direction issued by the officers to which contract vehicle is attached or other designated officer of MGNREGA.
- 17) The successful quotationer is required to execute an arrangement in non-judicial stamp paper in the form.
- 18) The court situated at Dharmanagar, North Tripura alone will have the jurisdiction to entertain civil suits, disputes if any pertaining to this contract.
